

RESOLUTION NO. 2013 - 03

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANOR, TEXAS SETTING PUBLIC HEARINGS TO BE HELD AT 7:00 PM ON WEDNESDAY, OCTOBER 2, 2013, AND WEDNESDAY, OCTOBER 16, 2013, AT MANOR CITY HALL, 201 E. PARSONS STREET, MANOR, TEXAS 78653 TO CONSIDER AN ORDINANCE GRANTING TO *ATMOS ENERGY CORPORATION, A TEXAS AND VIRGINIA CORPORATION, IT'S SUCCESSORS AND ASSIGNS*, A FRANCHISE TO CONSTRUCT, MAINTAIN, AND OPERATE PIPELINES AND EQUIPMENT IN THE CITY OF MANOR, TRAVIS COUNTY, TEXAS, FOR THE TRANSPORTATION, DELIVERY, SALE, AND DISTRIBUTION OF GAS IN, OUT OF, AND THROUGH SAID CITY FOR ALL PURPOSES; PROVIDING FOR THE PAYMENT OF A FEE OR CHARGE FOR THE USE OF THE PUBLIC RIGHTS-OF-WAYS; AND PROVIDING THAT SUCH FEE SHALL BE IN LIEU OF OTHER FEES AND CHARGES, EXCEPTING AD VALOREM TAXES; AND REPEALING ALL PREVIOUS GAS FRANCHISE ORDINANCES.

WHEREAS, in accordance with Chapter 282 of the Texas Local Government Code, a public hearing is required to consider an ordinance granting a franchise to use or occupy a public street or alley of a municipality; and

WHEREAS, the City of Manor is considering an ordinance granting a franchise to *ATMOS Energy Corporation* for the transportation, delivery, sale, and distribution of gas in, out of, and through the City of Manor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANOR, TEXAS, THAT:


Public hearings shall be held at 7:00 PM on Wednesday, October 2, 2013, and Wednesday, October 16, 2013, at Manor City Hall, located at 201 E. Parsons Street, Manor, Texas 78653 for the purpose of considering an ordinance granting to *ATMOS Energy Corporation*, a Texas and Virginia Corporation, it's successors and assigns, a franchise to construct, maintain, and operate pipelines and equipment in the City of Manor, Travis County, Texas, for the transportation, delivery, sale, and distribution of gas in, out of, and through said City for all purposes; providing for the payment of a fee or charge for the use of the public rights-of-ways; and providing that such fee shall be in lieu of other fees and charges, excepting ad valorem taxes; and repealing all previous gas franchise ordinances.


Any member of the public may appear at the public hearing and present evidence for or against the approval of the ordinance to grant *ATMOS Energy Corporation* a gas franchise.
