**APPLICATION FOR DEFERRED DISPOSITION**

A Deferred Disposition is a postponement of sentence or probation for a specified amount of time. You must enter a plea of Guilty or No Contest in order for the Judge to defer a finding of guilt at a later date, assess applicable fees, and order you to comply with specific terms and conditions. If you successfully comply with all the terms and conditions, your case may be dismissed after review by the Judge. However, if you fail to comply with the terms and conditions, a guilty judgment may be imposed and a conviction may be reported to the Texas Department of Public Safety.

You may apply for Deferred Disposition via US Mail or email by submitting this application on or before your scheduled appearance date. The Judge will review your application and Deferred Disposition will only be granted at the discretion of the reviewing Judge.

**Requests by mail / email / fax will not be accepted for the offenses listed below:**

- **Driving While License Invalid**
- **No Driver's License**
- **Expired Driver's License**
- **Speeding over twenty-five (25) miles per hour over the posted speed limit or 90 miles per hour**
- **Any violation of the Texas Penal Code**
- **If you have completed a deferred disposition with the City of Manor in the last 12 months**
- **Any moving violation by a holder of CDL (Commercial Driver's License)**
- **Any traffic violation that occurred in a construction zone with workers present**
- **Juvenile cases (16 years of age and younger must appear in person with parent or guardian)**
- **Defendants 20 years of age or younger that received a citation for an Alcohol or Tobacco related charge are required to appear before the Judge.**

***Defendants 24 years of age or younger*** at the time of the alleged traffic offense they must also complete a Driver Safety Course (for traffic offenses) in addition to complying with the terms of deferred disposition by mail.

I hereby enter a plea of  **Guilty** or  **No Contest** to the violation of \_\_\_\_\_ and waive my right to a jury trial. I have not requested discovery from the State under Art. 39.14 of the Texas Code of Criminal Procedure. I request that the Court place me on Deferred Disposition for this case. I understand that if I successfully complete the terms of the Deferred Disposition by the specified time in my deferral, my case will be dismissed. If I do not successfully complete the terms of the Deferred Disposition, I will receive a notice to appear in court to show cause why I did not complete the terms of Deferred Disposition as ordered. Furthermore, I understand that if I do not show sufficient cause, the Deferred Disposition will be revoked and a judgment of guilt will be entered and will be reported to the Texas Department of Public Safety in accordance with Texas Code of Criminal Procedure, Art. 27.14(c).
